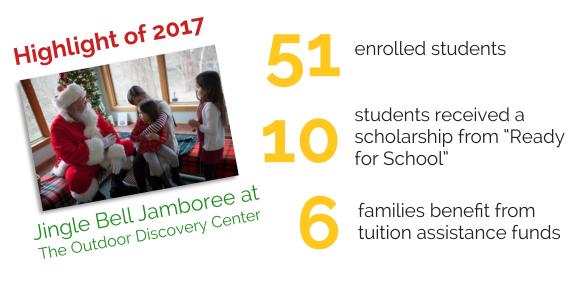

In preparation for 2017, the Stewardship Council again opted for a faith-pledge stewardship campaign. In other words, the Session adopted a budget with no specific idea how much members intended to contribute. This approach was reprised for 2018 and once again First Presbyterian Church has demonstrated through faith in God our committed members continue to provide ample resources to carry out the work of Christ here on earth.

The Session approved budget projected pledge and plate receipts of \$495,100 and received \$528,085, 6% above expectations. Spending was below the budgeted amount, resulting in a surplus of \$49,433.

As shown above, Session is anticipating receipts in 2018 of \$495,100, which is the same as 2017's budget. This is a conservative budget in light of capital campaign considerations, we finished 2017 better than anticipated and we recognize that every pledge is important as we do all of this together as a community of givers.

We end 2017 with \$172,750 in liquid holdings (checking, CD's), \$118,923 in the Building Fund and \$384,470 in the Mission Endowment Fund. We move into 2018 with a Session that is committed to making decisions that will continue to expand and enrich our ministries here at FPC.

Significantly, as has been true now for many years, this Church carries no debt – zero, zilch, nada.
